Pursuant to Article 1396-4.02(A)(4)(a) of the Texas Non-Profit Corporation Act (the "Act"), Greenway Parks Home Owners Association, a Texas non-profit corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation (the "Charter"):

#### **ARTICLE ONE**

The name of the Corporation is Greenway Parks Home Owners Association.

## **ARTICLE TWO**

The following amendment to the Charter was duly adopted by the Board of Directors of the Corporation on February 9, 2004. The amendment revises Article IV of the Charter so that, as so amended, Article IV shall read in its entirety as follows:

The place where the business of the corporation is to be IV: transacted is in Dallas, Dallas County, Texas, and elsewhere within or without the State of Texas, in accordance with the laws of this State, and its principal place of business is to be in Dallas, Dallas County, Texas. The period of duration of the Corporation is perpetual from the date of filing of these Articles of Amendment with the Secretary of State of the State of Texas, unless earlier dissolved in accordance with the Act.

These Articles of Amendment have been duly adopted by the Board of Directors of the Corporation pursuant to Article 1396-4.02(A)(4)(a) of the Act. Such approval was evidenced by the vote of a majority of the members of the Board of Directors of the Corporation at a meeting of the Board of Directors of the Corporation held on February 9, 2004.
