

Amendment of Restrictions Covering Greenway Parks Addition

September 29, 2006

WHEREAS, in accordance with the October 1, 1976 amendment (the "1976 Amendment") to the Greenway Parks deed restrictions (the "Restrictions") dated January 11, 1943, and recorded in Volume 2413, Page 507, of the Deed Records of Dallas County, Texas, and the Declaration by J.P. Stephenson, *et al.*, dated March 12, 1927, and recorded in Volume 1390, Page 616, Deed Records of Dallas County, Texas, the Greenway Parks Home Owners Association (the "Association") amended paragraph (10) of the Restrictions to include various provisions regarding the charge, use and collection of an annual maintenance charge (the "Annual Maintenance Charge") by the Association; and

WHEREAS, among other items, the 1976 Amendment provided that at any time in 1991 the Annual Maintenance Charge could be increased for subsequent years by a vote in person or by proxy of at least two-thirds of the members of the Association at any special or annual meeting of the members; and

WHEREAS, at a special meeting of the members of the Association on December 11, 1991, more than two-thirds of the members of the Association voted to increase the Annual Maintenance Charges for subsequent years by adopting various resolution (the "1991 Resolutions") to such effect; and

WHEREAS, in accordance with the 1991 Resolutions, the Board of Directors of the Association voted to increase the Annual Maintenance Charge on two separate occasions and applied the applicable annual Consumer Price Index adjustment, such that the current Annual Management Charge (the "Current Annual Maintenance Charge") is as follows:

	8, 9, the north $\frac{1}{2}$ of 10, and The south $\frac{1}{2}$ of 11	\$ 0.197 (19.7 cents)

2. In addition to the annual fees set forth in the foregoing paragraph, each lot owner shall be assessed and shall pay an additional annual fee of \$162.49, which shall become a part of the fee schedule.

WHEREAS, in accordance with paragraph (11) of the Restrictions, the owners of fee simple to not less than two-thirds of the lots in the installment of Greenway Parks of which said lots are a part now desire to alter and amend paragraph (10)(a) of the Restrictions as provided herein.

NOW, THEREFORE, the owners of fee simple to not less than two-thirds of the lots in the installment of Greenway Parks of which said lots are a part hereby agree as follows:

1. <u>Amendment</u>. Paragraph (10)(a) of the Restrictions is hereby amended and altered to include the following additional sentence:

"Commencing on January 1, 2012, the Board of Directors of the Association may, at any time and in its sole discretion, increase the then current fee schedule in an amount that exceeds the Consumer Price Index adjustments contemplated by this paragraph (10)(a); *provided*, *however*, that the aggregate amount of any such increase during any consecutive five-year period commencing on January 1, 2012, shall not exceed 20% (exclusive of any Consumer Price Index adjustments during such period) of the management fees last in effect for the immediately preceding five-year period."

2. <u>Effective Date</u>. In accordance with Paragraph (11) of the Restrictions, this amendment shall be effective commencing October 1, 2011, and thereafter until amended or abolished. The Current Annual Maintenance Charge under the Restrictions, as adjusted from time to time for Consumer Price Index changes, shall remain in effect until September 30, 2011. Except as amended hereby, the Restrictions shall remain in full force and effect.

3. <u>Partial Invalidity</u>. If any provision hereof is held to be invalid or unenforceable, the other provisions hereof shall nevertheless remain in full force and effect, and the invalidity or unenforceability of any provision hereof shall not affect the validity or enforceability of any other provision hereof.

4. <u>Counterparts; Recording</u>. These restrictions may be executed in any number of counterparts, each of which shall be deemed an original and all such counterparts shall together constitute a part of the Restrictions. Each of the undersigned agrees that its signature page and acknowledgment may be removed from its respective counterpart and attached to a single instrument for recording purposes.
